15	27 July	Equal Opportunities Commission, Human Rights Commission	Cases were lodged at both instances though Me Zahid Nazurally (MHOA legal advisor)
16	28 July	Letter sent to MOH and PMO	Reminder of 3 undertakings (27 February, 12 June, 20 July) not to extend shift to units.

		2 nd Meeting with MOH 2 nd Press Conference	Meeting was ended because SCE did not feel the need to answer our request to withdraw the circular MHE/SHSY/MEDGR/V8 Above facts were raised.
17	31 st July	Judicial review case Communique to protect/warn members	1st Affidavit solemnly affirmed. A1 Information was obtained that members trying to do illegal gatherings would have faced serious problems(legal, professional)
18	1 st August	Implementation of shift system to units Peaceful Manifestation at MOH	Not all units are concerned till date Meeting with Minister obtained.
19	2 nd August	3 rd Meeting at MOH	Minister did not allow 5 representatives to enter committee room. Police forced us out.
20	5 August	3 rd Special General Meeting	Minister did not attend to give clarifications on shift system to doctors. We were backed by FCSOU, GMDOA and Nursing Association.
21	7 August	Judicial review case	SLO asked time to take a stand on the motion.
22	16 August	Radio Show on RadioOne	Doctors and members of the public, who intervened live, backed us.
23	31 st August	4 th Meeting at MOH	A reform on the health system with the introduction of partial shift system. Recommendations of shift system were also tabled.
24	11 September	Judicial review case	SLO filed an affidavit in response to our first.R1 MHOA solemnly affirmed a second affidavit to counter SLO's.A2
25	18 September	Judicial review case	SLO asked time to take a stand on the second affidavit of MHOA. A2
26	19 September	CCM	MOH informed that on 20 September a technical committee would be set up to look into our recommendations on shift system.
27	2 nd October	Judicial review case	SLO filed an affidavit in response to ours A2. R2.
28	3 rd October	5 th Meeting with MOH	MOH handed over their views on MHOA recommendations. A follow-up meeting in a week's time was requested by MHOA.
